**Sub: Creation of additional Quarantine Jails for new under-trial prisoners arriving on judicial remand at Prisons in Punjab, reg.**

**Memo:**

Kindly refer to this office letter no. GI/P-3/4663-67 dated 15-04-2020 on the subject cited above.

2. Govt. of Punjab, Dept. of Jails, has designated 2 more jails as 'Special Jails' for quarantining new admission prisoners, vide memo no. 1/100/2020-2J/825, dated 16-04-2020 ('Borstal Institute, Ludhiana' as '**Special Jail Ludhiana**') and no. 1/100/2020-2J/832, dated 16-04-2020 ('Women Jail Bathinda' as '**Special Jail Bathinda**') (copies enclosed).


3. These shall be in addition to previously designated 2 jails, namely, **District Jail Barnala** and **Sub Jail Patti**. With this, four (4) jails in Punjab have been designated as Special Quarantine Jails for the purpose mentioned above.

4. In supersession to this office letter dated 15-04-2020 referred above, Re-distribution of 'district-wise division of prisoners' has been done. All new under-trial prisoners remanded to judicial custody in Punjab w.e.f 20-04-2020 may be sent to the Quarantine Jails as noted below:

<b>Quarantine Jail</b>	<b>For prisoners of District (where FIR is registered)</b>
District Jail Barnala	Patiala, Sangrur, Moga, Mansa, Barnala, Ludhiana (Rural)
Sub-Jail Patti	Gurdaspur, Batala, Amritsar (Rural), Amritsar (CP), Tarn Taran, Pathankot, Kapurthala
Special Jail Ludhiana	SAS Nagar, SBS Nagar, Rupnagar, Khanna, Ludhiana (CP), Jalandhar (Rural), Jalandhar (CP), Hoshiarpur, Fatehgarh Sahib
Special Jail Bathinda	Sri Muktsar Sahib, Ferozepur, Faridkot, Bathinda, Fazilka

5. It is being re-iterated that all new **female prisoners** in the state shall be sent to Women Jail, Ludhiana where they shall be confined in a designated quarantine barrack.


6. It is requested that all SHOs and IOs may please be informed immediately regarding the above arrangement. As the quarantine/special jails are at substantial distance from some districts, CPs and SSPs are requested to kindly make suitable arrangements for collecting all the remand prisoners at one place in the CoP/Dist., and shifting them to the concerned Quarantine/Special Jails together in the evening, under adequate security.
