# EMERGENCY POWERS (COVID 19 PANDEMIC) REGULATIONS, 2020 (CHAPTER 34)

### EMERGENCY POWERS (COVID 19 PANDEMIC) (LOCKDOWN)(AMENDMENT)(NO. 3) ORDER, 2020

In exercise of the powers conferred on me by the Emergency Powers (Covid 19 Pandemic) Regulations, 2020, I HEREBY make the following Order—

#### 1. Citation.

This Order, which amends the Emergency Powers (Covid 19 Pandemic) (Lockdown) Order, 2020, may be cited as the Emergency Powers (Covid 19 Pandemic)(Lockdown) (Amendment)(No. 3) Order, 2020.

#### 2. Amendment of order 2 of the principal Order.

Order 2 of the principal Order is amended by the insertion immediately after paragraph (2) of the following new paragraph —

"(3) This Order shall cease to apply to islands of Inagua, Mayaguana, Crooked Island, Acklins, Long Cay, Long Island, Chub Cay, Rum Cay, and Ragged Island at 5:00 am on Monday the 10<sup>th</sup> day of August, 2020 and the Emergency Powers (Covid 19 Pandemic)(No. 3) Order, 2020 shall apply to these islands.".

#### 3. Amendment of order 6 of the principal Order.

Order 6 of the principal Order is amended in paragraph (1) —

- (a) by the deletion and substitution of subparagraph (b) as follows
  - "(b) the National Insurance Board shall be permitted to open to the general public on Mondays, Wednesdays Fridays and Saturdays for the distribution of cheques;";
- (b) by the deletion and substitution of subparagraph (f) as follows
  - "(f) the following businesses may open only to essential workers on Saturdays
    - (i) a grocery store between the hours of 7:00 am and 5:00 pm;

- (ii) a water depot between the hours of 7:00 am and 1:00 pm;
- (iii) a pharmacy offering curbside service only between the hours of 7:00 am and 1:00 pm;
- (iv) a gas station offering external service only between the hours of 7:00 am and 1:00 pm;".

#### 4. Amendment of order 7 of the principal Order.

Order 7 of the principal Order is amended by the deletion and substitution of paragraph (2) as follows —

"(2) For the avoidance of doubt, a counsel and attorney shall work remotely in accordance with order 5 and may attend his office only for the purpose of collecting files and other items necessary to enable him to work from home and in accordance with paragraph (1).".

#### 5. Amendment of order 8 of the principal Order.

Order 8 of the principal Order is amended by the deletion and substitution of paragraph (1) as follows —

- "(1) The following businesses shall be permitted to open for the restocking of goods only—
  - (a) a grocery store, whether wholesale or retail on Tuesdays, Thursdays and Sundays between the hours of 7:00 am and 5:00 pm;
  - (b) a wholesale bakery on Tuesdays and Thursdays between the hours of 7:00 am and 5:00 pm;
  - (c) a water depot on Tuesdays and Thursdays between the hours of 7:00 am and 5:00 pm;
  - (d) a hardware store on Tuesdays and Thursdays between the hours of 7:00 am and 5:00 pm;
  - (e) a gas station on Tuesdays and Thursdays between the hours of 7:00 am and 5:00 pm.".

#### 6. Amendment of order 11 of the principal Order.

Order 11 of the principal Order is amended in paragraph (1) by the deletion of the words "order 3" and substitution of the words "order 6".

#### 7. Insertion of new order 11A into the principal Order.

The principal Order is amended by the insertion immediately after order 11 of the following new order —

#### "11A. Grand Bahama.

Notwithstanding order 6, grocery stores whether wholesale or retail are permitted to continue in operation from Monday to Friday between the hours of 7:00 a.m. and 5:00 p.m.".

#### 8. Amendment of order 17 of the principal Order.

Order 17 of the principal Order is amended by the insertion immediately after the word "Orders", of the figures "20A,".
