### Subject: Enforcement action for strict implementation of COVID Appropriate Behaviour in NCT of Delhi.

Sir.

Concern has been expressed in the DDMA meeting held on 22.02.2021 about the increase in COVID-19 cases in past few days in various states such as Maharashtra, Kerala, Chhattisgarh, Punjab and Madhya Pradesh. In light of the emerging situation in these states, strictly enforcement of various DDMA orders issued from time to time on mask compliance, regulation of social gatherings and social distancing measures etc. are required by all field functionaries in NCT of Delhi.

In this context, I am directed to request all authorities concerned to step up all precautionary measures and to take necessary actions for strict enforcement of COVID Appropriate Behaviour throughout NCT of Delhi by imposition of fines in their jurisdiction, on violation of the offences as specified vide Notifications dated 13.06.2020 read with notification dated 20.11.2020 issued by Health & family Welfare Department, GNCTD such as not following social distancing, wearing of masks, spitting in public places etc.

A compliance report in this regard (on daily basis), in enclosed proforma (in MS-Excel). shall be submitted by all District Magistrates (after collecting from all other authorities in their respective jurisdiction) to Special CEO, DDMA on email ddma.delhi@nic.in. All Departments concerned to ensure timely submission of daily report to concerned District Magistrate for compilation. Special CEO, DDMA shall share the report with Sh. Amit Singla, Secretary (H&FW) on daily basis.
