Decree 371/2022, of September 21, 2022

Decree 371/2022, of 21-9-2022, extending [Decree 260/2022](#) , of 22-6-2022, of new exceptional measures due to the evolution of the health emergency situation caused by the SARS-CoV-2 coronavirus .

Statement of reasons

Since the health situation remains stable, and there is little pressure on the health system, it is necessary to extend [Decree 260/2022](#) , of 22-6-2022, of new exceptional measures due to the evolution of the situation, for one more week health emergency caused by the SARS-CoV-2 coronavirus.

The Government's intervention is based on the provisions of the General Health Law, of March 20, 1989, and of Law 31/2021, of November 22, a consolidated text classified as public security.

In this context, the extension is established, until September 28, 2022, of the measures adopted by [Decree 260/2022](#) , of 22-6-2022, of new exceptional measures due to the evolution of the health emergency situation caused for the SARS-CoV-2 coronavirus, extended by [Decree 271/2022](#) , of 6-29-2022; by [Decree 279/2022](#) , of 7-6-2022; by [Decree 290/2022](#) , of 7-13-2022; by [Decree 302/2022](#) , of 7-20-2022; by [Decree 319/2022](#) , of 27-7-2022, by [Decree 325/2022](#) , of 3-8-2022; by [Decree 330/2022](#) , of 8-17-2022; by [Decree 342/2022](#) , of 8-31-2022; by [Decree 356/2022](#), of 7-9-2022, and by [Decree 366/2022](#) , of 14-9-2022, which can be modified depending on the evolution of the pandemic.

For everything that has been presented, at the proposal of the Minister of Health, the Government, in the session of September 21, 2022, approves this Decree with the following content:

Single item. Extension of exceptional measures

[Decree 260/2022](#) , of 22-6-2022, of new exceptional measures due to the evolution of the health emergency situation caused by the SARS-CoV-2 coronavirus, extended by [Decree 271](#) , is extended until September 28, 2022 /2022 , of 6-29-2022; by [Decree 279/2022](#) , of 7-6-2022; by [Decree 290/2022](#) , of 7-13-2022; by [Decree 302/2022](#) , of 7-20-2022; by [Decree 319/2022](#) , of 7-27-2022; by [Decree 325/2022](#) , of 3-8-2022; by [Decree 330/2022](#) ,

of 8-17-2022; by [Decree 342/2022](#) , of 8-31-2022; by [Decree 356/2022](#) , of 7-9-2022, and by [Decree 366/2022](#), of 9-14-2022.

Final provision

This Decree enters into force on September 22, 2022.
